Novice Horse Barrels - Horse not to have won \$500 in ITS lifetime.  
Youth classes are 17 & under.

This is a Christian oriented organization so, therefore, no alcoholic beverages, abusing of horses, or any type of misconduct by a person is allowed. This includes foul language. It is intended for this to be a safe environment for you and your family to enjoy.

A competitor will receive a 5 second penalty for each barrel or pole knocked down. SBRA members do not receive points for barrels knocked down.

RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT  
FOR APRIL 16 - 18, 2010 EVENT AT REALITY RANCH, ZOLFO SPRINGS

In consideration of being permitted to enter for any purpose any area (as hereinafter defined) or being permitted to compete, officiate, observe, work for, or for any purpose participate in any way in this Florida Equine Athlete and Sunshine Barrel Racers event. The UNDERSIGNED, for himself or herself, his/her personal representatives, heirs, and next of kin acknowledges, agrees, and represents that he/she has, or will immediately upon entering any of the areas, and will continuously thereafter, inspect such area and all portions thereof which he/she enters and with which he/she comes in contact, and he/she does further warrant that his/her entry upon such area and that he/she finds and accepts the same as being safe and reasonably suited for the purposes of his/her use, and he/she further agrees and warrants that if, at any time, he/she is in or about any Area and he/she feels anything to be unsafe, he/she will immediately advise the officials of such and will leave the Area. The Area shall include, but not be limited to, any arenas, competition areas, chutes, pens, areas reserved, and intended for participants or restricted to the general public, and all walkways, concessions, and other areas appurtenant to any area where any activity related to any Florida Equine Athlete, Sunshine Barrel Racers event shall take place.

THE UNDERSIGNED HEREBY RELEASES, WAIVES, AND DISCHARGES, AND CONVENANTS NOT TO SUE Florida Equine Athlete, Sunshine Barrel Racers Association, Melissa L. Greer, Melissa L.
